Dear Friends in Christ,

2020 was a difficult year in so many ways, in our personal lives and as in our life together as the body of Christ at OSLC. In the first two and a half months we had a strong start to the year and in early March the Curiosity Team had the first of what was to be several congregation-wide meetings to explore identity, vision and mission. I was excited for the work done at that gathering and looked forward to the next. When Lent began at the end of February the youth took on leadership of our Wednesday night services and did it well. Church life was "normal." Then...shutdown because of Covid19. We were not able to be church as we have known and experienced, but we still continued our ministry outside of the building. Just read the committee reports and you'll see what that looked like. God has been with us and working through us in many and various ways. My deep appreciation for those who serve on these committees and the volunteers who help in ways seen and unseen.

There are things that have worked well and other areas that have been more of a challenge the past year. With the technology available we have been able to continue to offer worship services. I had some idea of how to do that already, but I've also learned a great deal. I'm also extremely grateful for Carla's tech skills and her willingness to put in a gazillion volunteer hours to learn how the new streaming system works and be at church every Sunday to run it for us. A big challenge that continues is how to stay connected to our members who don't have internet access. I have done many pastoral visits via phone in the past year and the Outreach team also organized a group to call other members just to check in and see how people are doing. I've said this before: please call me for any pastoral need and if you are lonely and just want to talk.

We all miss being in the church. It is both heartbreaking and frustrating. The decision to not gather in person has not been made by me alone but from recommendations from the Regathering Task Force and by the entire church council. I am so very grateful for their leadership. We monitor information from East Central Synod of Wisconsin, Wisconsin Council of Churches, which consults with distinguished medical personnel, and Lincoln County Public Health. Our concern has always been and will continue to be the safety and health of our members and making decisions that reflect gospel values and Jesus command to love and serve one another.

Some goals for us in 2021: Come back inside the building when it is safe to do so and in the meantime work together to creatively and compassionately provide worship and all others ministries that serve our members and the community. Discern leadership needed for Youth and Family ministry and take appropriate action. Generous and faithful stewardship of our resources to support the ministry of OSLC and care for our neighbors near and far.

May God strengthen us with hope this coming year, lead us on a level path. With grace, may we keep our eyes on Christ and trust in God's faithfulness and steadfast love.

Christian Education Team 2020 Annual Report

The work of the Christian Education Team encompasses faith formation at all levels: Sunday School, Vacation Bible School, Confirmation classes, and Adult Bible Study. Thankfully, the team is made up of faithful, dedicated people and thus the work is accomplished.

Sunday School: Throughout January and February, classes were held in person. Nine students were enrolled, age 3 through Grade 5. In the fall of 2020, three additional young students enrolled, increasing enrollment to 12. We meet as one group, splitting the group as necessary to accommodate maturity levels. There are four teachers and one aide on staff. Each teacher leads the lesson approximately once a month; students enjoy the variety of teachers. Tammy Latzig, our aide, is the one constant.

Beginning in February, a Food Pantry fundraiser was held: "Pickled Nickels." With the help of the congregation, nickels and more were collected in a large pickle jar. It turned out to be a really big "dill"; over \$400 was collected! Thank you for contributing your nickels for a good cause.

As it turned out, in-person classes were cancelled from early March through December due to the Covid-19 outbreak. Instead, a packet of materials was sent home weekly to each child. A video of the week's Bible story was available on Facebook, along with an introduction taped by our teaching staff. Pr. Pat organized a virtual "Christmas Pageant" with students participating online; it was a smash hit!

Sunday School classrooms were painted during the summer to brighten up the space. A huge thank you to Mike Jirovec and family who did the work. Future plans are to paint murals on the walls depicting various Bible stories.

Vacation Bible School: Original plans were to utilize Crossways Bible Camp's ministry team to lead summer VBS; kids from other churches would be invited. Staffing concerns at Crossways didn't allow for this to happen. Because attendance has steadily declined, and because of Co-vid concerns, the team decided to cancel VBS for 2020.

Confirmation Class: With the January resignation of our Youth Director, Jamie Diestelhorst, Pastor Pat shouldered the largest share of teaching. Christa Lahti and Josie Countryman assisted through mid-March. In the fall Pr. Pat began to meet with both the Middle School and 9th grade classes using Zoom.

Adult Bible Study: Monday Night Bible Study, small group studies of the Book of Acts, and Lenten Book Studies were started, but discontinued due to the pandemic.

Christian Education meetings are held on the second Thursday of each month at 6:30. Come join us!

Curiosity Team 2020 Annual Report

The Curiosity Team was formed in the fall of 2018 to start discussing what it means to be a church and options for how Our Saviour's Lutheran Church can renew and grow our church and ministry in this time and place. Seeds for Growth, a synod sponsored program, was selected to help the team facilitate this process with the congregation. Throughout 2019 we met regularly exploring different tactics to help us work with the congregation to discern the purpose and ongoing viability of our church. In 2020 we were looking forward to putting what we learned into action and like most committees we had big plans:

- We expected to continue engaging in one-on-one conversations both within and outside the congregation
- We planned to work with the congregation to define our core values and guiding principles as a congregation. This discernment was to help us gain a clearer picture of our purpose and what direction we feel God is leading our church.
- Engage the congregation in an asset mapping activity.

In February, with the help of Pastor Rich Block, we were able to hold a session with congregation members to define our core values. Through a process of small group conversations transitioning to a large group discussion we decided on the core values that best define our church. Based on these values we then developed an identity statement: "A worship centered joyful community serving where Christ leads." The values and identity statement were then presented to the congregation.

Unfortunately, the follow up session to do asset mapping that was scheduled for March had to be postponed. When we are able to gather together again we will hold a session to analyze the assets and resources of our congregation that contribute to our mission. We can then start selecting activities to engage the congregation in building additional relationships and planning for the future.

While we had to pause the 2020 efforts of the Curiosity Team we hope that we can soon work closely with the congregation again. We will continue this journey of restoration for our church and assist the congregation with additional recovery efforts as we emerge from the impacts of the pandemic.

Outreach Team 2020 Annual Report

The Outreach Team seeks to provide opportunities for our members to live out their faith in service to our congregation, our community, and our world while fostering a sense of community among us. The COVID-19 pandemic of 2020 brought many challenges to our ability to minister to our community and one another, but here are some of the ways we were able to meet these challenges.

Soup-er Bowl: The Outreach Team hosted the annual Soup-er Bowl soup luncheon in February. With 11 cooks and 58 in attendance, the Soup-er Bowl event raised \$840 for Food For Kids.

Summer Lunch for Kids and Teens: Despite the pandemic, volunteers from Our Saviour's continued to serve free lunches each week during the summer. Due to social distancing, the format was changed to a 'Grab & Go' cold sandwich meal. Many thanks to the Merrill Area Food Pantry for providing most of the food for the lunches and to Brenda and Tom Mueller for coordinating this effort with the food pantry.

St Vincent de Paul Fundraiser:

Since the annual Fill the Gazebo food drive was canceled due to COVID-19, the Outreach Team chose to publicize the important work of the Society of St. Vincent de Paul and encourage donations to support them in their outreach. St Vincent's provides many services including the free clinic and assistance to families with expenses for rent and utilities.

Chalk Talk:

To brighten spirits in a time of social distancing, the Outreach Team provided sidewalk chalk and encouraged individuals and families in the community to stop by the church to write positive messages on the sidewalk during the summer and fall months.

Little Library:

The Little Diverse Library was started by a grass-roots effort at Our Saviour's to promote social justice and interracial understanding. The brainchild of Brenda Mueller and Marie Rein, this special little library provides children and adult borrowers in the Merrill community with reading materials on topics that feature diversity and inclusion. The borrower's box, a tiny replica of our building, was built by Mike Jirovec. The Outreach Team was pleased to help publicize this new venture and encourage donations to the book collection. Check out the material and tell your friends!

Highway Cleanup:

In September, a group of volunteers from Our Saviour's participated in the highway cleanup at Highway Q and Joe Snow Road.

Food Pantry Challenge:

We asked and you responded to a call for donations of personal hygiene supplies for the Merrill Area Food Pantry. These items are in short supply and donations are always appreciated. We gathered 3 large tubs of items for those in need.

Before COVID closed our building, your weekly donations to the food pantry filled the tubs in the narthex. But how did those donations get to the food pantry? For years our faithful volunteers have been delivering these donations. Roger and Marion Anderson worked behind the scenes to deliver your donations to the food pantry, taking over from long-time volunteers Jerry and Ann Wick. We salute our volunteers for their contribution to this ministry.

Sing for Joy:

Thanks to your generous donations, Our Saviour's was able to sponsor this weekly Sunday morning radio broadcast of music from St. Olaf College.

Food For Kids: The Food for Kids program serves students in Merrill-area schools by filling student's backpacks with packaged meals to take home each weekend. Over the past several years we have enjoyed the enthusiastic support of workers from Our Saviour's to pack the food for Kate Goodrich Elementary School. The Boy Scouts will now be doing the packing for all the schools, so packers are no longer needed from Our Saviour's, but the program needed volunteers to inventory the supplies each month. Thank you to Marie Rein and Shirley Engel who have volunteered to do the inventory.

Christmas Donations:

Financial Report

Financial Stewardship Team 2020 Annual Report

Our Saviour's Financial Stewardship Team meets monthly to review and discuss our financial situation and to develop recommendations to Council. The year 2020 presented a number of unexpected challenges.

From the start, we were operating under a reduced budget due to reduction in staff creating the uncertainty of how these changes would impact Income vs. Expense. Along came Covid-19 and elimination of indoor services and an unknow impact on income.

In anticipation of an income reduction we secured a Payroll Protection Plan loan, (PPP) in the amount of \$44,925. As of this date, "Forgiveness" of the loan has not been finalized due to government rule changes and delays in finalizing the rules and procedures. However, we anticipate loan forgiveness in the near future.

The next issue was the discovery of irregularities in our Scrip Program. This remains an open issue as investigation and insurance claim resolution has become a long and slow process.

The most recent challenge is to find a replacement for our dedicated and long term Treasurer, **Marlene Graap**. Marlene announced her retirement from this job effective January 31, 2021. We can not express enough appreciation for her good work for many years. The good news is she will continue to be an active OSLC member/volunteer. **Thank you Marlene**!

Due to staff resignations, terminations, cutting of staff hours and our inability to fill the open Youth and Family Director position, our expenses were down considerably, resulting in our income exceeding expense.

The Financial report will give the detail. Below is the summary for the year 2020.INCOME\$287,445.94LESS EXPENSE(\$215,996.92)NET IMPROVEMENT\$ 71,449.02 (INCOME GREATER THAN EXPENSE)

In 2012 the Finance Committee and Congregation Council decided to start using scrip in a new way. Whenever a committee needs something from a local store, they stop in and get scrip first. We then keep track of the amount spent. Instead of having monies go back and forth between scrip and the church, we are subtracting the total used by committees from the profits available to the church.

In 2020, we used \$2,610.63 of Scrip to pay for the needs of various committees, including Youth and Family, Outreach, Worship & Music, Christian Education, Stewardship, for office supplies and to help cover food costs for various events.

Scrip works! Thank you to those who buy scrip. We encourage all members to use the Scrip program whenever possible.
